BOARD AND COMMISSION QUALIFICATIONS AND DESCRIPTIONS

Members of all boards and commissions must be:

- Residents of the City of Sanger for at least six (6) months preceding the date of appointment
- Qualified voters; and
- Not be an officer of the City nor any person who holds a compensated position with the City

Note: 4A Board and 4B Board requirements differ and are included in the description below.

Attendance at meetings is a requirement. Any member missing three (3) consecutive meetings without prior notification shall be replaced by the City Council.

Members may serve up to three (3) consecutive two (2) year terms. Afterward, a member can be appointed to another board immediately, or the same board after a one (1) year absence.

BOARD OF ADJUSTMENT	MEETING DATE: CALLED MEETING
The Board consists of seven (7) members serving two year terms. The Board has authority to hear appeals and variances to city regulations related to zoning and building and to determine if the Administrative Official has created an error in the interpretation and enforcement. Meets only as required.	
HISTORIC PRESERVATION COMMISSION	MEETING DATE: THIRD TUESDAY
An advisory board to the City Council and Building Official on issues related to historic districts and landmarks. Consists of seven (7) members. Meets monthly.	
KEEP SANGER BEAUTIFUL BOARD	MEETING DATE: SECOND MONDAY
Serves as a consulting, advisory and supervisory body to study and recommend policies relating to the operation and promotion of beautification efforts. The Board is composed of nine (9) members.	
LIBRARY BOARD	MEETING DATE: QUARTERLY
The board of seven (7) serves as a consulting, advisory, supervisory body to study and recommend policies relating to the operation, promotion, enlargement, future planning and such other matters involving the city-owned library. The Library Board meets 4 times each year.	
PARKS BOARD	MEETING DATE: SECOND TUESDAY
The Parks Board serves as a consulting, advisory and supervisory body to study and recommend policies relating to the operation, promotion, enlargement, future planning and such other matters involving city parks as may be referred to it by the City Council. The Parks Board consists of seven (7) members. Meets monthly.	
PLANNING AND ZONING COMMISSION	MEETING DATE: SECOND MONDAY
The P&Z Commission is composed of seven (7) members who receive, review and take appropriate action on all platting and subdivision proposals. The Commission makes recommendations to the Council on proposed ordinance(s) and amendments to existing ordinance(s) regarding planning, zoning, and environmental quality.	
4A BOARD	MEETING DATE: CALLED MEETING
A 4A corporation board is governed by a five (5) member board. A director is not required to be a city resident or a property owner. The directors are appointed to a term not to exceed six years. The board recommends expenditures of sales tax for economic development.	
4B BOARD	MEETING DATE: CALLED MEETING
The 4B corporation board consists of seven (7) members. According to Texas state statutes, a director may either be a resident of the city, a resident of the county in which the major part of the area of the city is located, or reside in a place that is within 10 miles of the city's boundaries and is in a county bordering the county in which a major portion of the city is located. A director serves a two year term. The board recommends expenditures of sales tax for economic development.
