ORDINANCE # 04-06-12

AN ORDINANCE OF THE CITY OF SANGER DESIGNATING SANGER REINVESTMENT ZONE NO. 2; PROVIDING ELIGIBILITY OF THE **COMMERCIAL-INDUSTRIAL** TAX ABATEMENT: ZONE FOR CONTAINING FINDINGS THAT THE AREA QUALIFIES TO BE ZONE DESIGNATED AS A REINVESTMENT AND IMPROVEMENTS SOUGHT ARE FEASIBLE AND PRACTICABLE AND OF BENEFIT TO THE LAND AND THE CITY; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A REPEALING CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Sanger, Texas, has caused notice to be published in a newspaper having general circulation in the City and has delivered such notice to the presiding officer of the governing body of each taxing unit that includes in its boundaries real property described herein; and

WHEREAS, the City Council of the City of Sanger, Texas, has conducted a public hearing on the designation of the area described herein as a reinvestment zone;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SANGER, DENTON COUNTY, TEXAS THAT:

SECTION 1. The City Council of the City of Sanger, Texas, finds that the area described herein will, if designated as a reinvestment zone, be reasonably likely to contribute to the retention or expansion of primary employment, or to attract major investment in the zone that will be of benefit to the property and contribute to the economic development of the City. The City Council further finds that the improvements sought are feasible and practicable and would be of benefit to the land to be included in the zone and to the City after the expiration of a tax abatement agreement.

SECTION 2. Pursuant to the provisions of Section 312.201 of the Texas Tax Code, the property described in Exhibit "A" attached hereto and made a part hereof for all purposes is hereby designated as a reinvestment zone and for identification is assigned the name "Sanger Reinvestment No. 2".

SECTION 3. The property within Sanger Reinvestment Zone No. 2 is eligible for commercial-industrial tax abatement effective on <u>April 26</u> 2012.

SECTION 4. If any article, paragraph or subdivision, clause or provision of this ordinance shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this ordinance as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

SECTION 5. All provisions of ordinances of the City of Sanger, Texas, in conflict with the provisions of this ordinance are hereby repealed.

SECTION 6. This ordinance shall take effect immediately from and after its passage, as the law in such cases provides.
